Date & Time Reported	Incident Type	Location	Summary/Disposition
12/05/08 3:14pm	Larceny	Grad Tower E	A Brown employee stated that at approximately 12:53pm he left his cubicle and returned at approximately 3pm. During that time he left his Brown owned laptop on his desk. When he returned to his cubicle the laptop was gone. During that time there were other employees working inside the office area who did not hear or see anything suspicious. There are no suspects at this time.
12/05/08 7:35pm	Attempted Breaking & Entering / Force	Olney House	Student reported that at approximately 1:30pm prior to his departure his room was locked and secured. He returned at approximately 5:30pm to discover substantial physical damage to the locking mechanism and door. He informed Brown police he was able to use his key to open a very weak lock mechanism and there were marks on the door. His possessions were all accounted for.
12/07/08 6:52pm	Larceny	OMAC	Student stated that her bag was stolen while working out. She left her hand bag on the south side of the gym floor and then stated that while she runs around the track she visually checks on her bag. One minute after she placed the bag down, she noticed it missing.
12/07/08 7:55pm	Burglary / No Force	Andrews Hall	Brown student reported that at approximately 7:30pm he left his room unlocked and went next door to a friend's room. When he returned at approximately 7:45pm his laptop was missing.

12/07/08 8:34pm	Larceny	OMAC	Student reported that while playing dodge ball he placed his belongings on the floor. After approximately a half an hour his belongings were missing.
12/08/08 4:01pm	Narcotic Violation	Harkness House	Officers were asked to assist employees of Residential Life with a recurring problem of student smoking marijuana in her room. As they all proceeded to the room, a strong smell of marijuana was in the hallway. Officers and a Dean entered the room. Two students admitted to smoking a joint twenty minutes prior. Marijuana and rolling papers were confiscated by Brown Police. The case has been turned over to Student Life.
12/08/08 8:48pm	Burglary / No Force	Poland House	Student stated that on 12/08/08 at approximately 8:30pm he left his dorm room door shut, but not locked. When he returned at approximately 8:47pm he discovered his laptop missing.

When this person opened his door the light from the hallway woke him up and all he saw was a dark silhouette in his doorway. He was unable to give any other description due to the fact that he wears glasses and was not wearing them at the time.
