Prior to the Iranian Revolution, Ghorbanifar had been an informant for Iranian Intel and aimed to have access to many senior ranking officers in the affitary as well as access to riranian underworld characters of various illicit hues. As of late 1979 he was a member of Telesan Komite and was able to travel freely between Europe and train in connection with his import/export business. He and has brothers Ali and Reza became implicated in abortive and of 9 July 1980 which resulted in curtailment of this trips to Iran. Since that time he has been located primarily in Taris with his brother Ali but travels to Athens, Turkey and Iran for purpose of meeting with other exile leaders in support this "group" in Iran.
