Next BEARCORE Session for Students and Post Docs Supported by NSF

A reminder that NSF requires training in ethical and responsible conduct of research for undergraduate and graduate students and post doctoral researchers supported by grants awarded as a result of proposals that were submitted on or after January 4, 2010.

The University has developed a training program to meet this requirement: Brown's Ethical and Responsible Conduct of Research Education program (BEARCORE).

The next BEARCORE session is Tuesday, January 22, 8:30AM-12:30PM.

Please advise your students and post doctoral researchers to **register via this** <u>link</u>:

Students and post doctoral researchers must complete the training within one year of beginning their NSF supported work. Please note that if students or post docs supported by NSF have completed one BEARCORE session, they do not need to take it again. Important Information For Programs with Deadline Dates of January 14, 2013 or Later

If the program you are submitting to has a deadline date of January 14, 2013 or later, and you submit your proposal prior to this date, you must prepare your proposal in accordance with the Proposal & Award Policies & Procedures Guide (PAPPG) (NSF 13-1), which requires that the one-page Project Summary include 1) an overview; 2) a statement on intellectual merit of the proposed activity; and 3) a statement on the broader impacts of the proposed activity. (See GPG, Chapter II.C.2b).

If you prepare your proposal prior to January 14, 2013, with the intention of submitting it on or after January 14, 2013, the information that you included in the Project Summary in FastLane will be inserted into the overview text box of the Project Summary. Per <u>PAPPG</u> guidelines, you will need to include this information in the three text boxes (overview; statement on intellectual merit; statement on broader impacts) or FastLane will not accept your proposal. (See <u>GPG</u>, Chapter II.C.2b).

NSF Posts FAQs on FastLane Changes for 2013 PAPPG

As previously announced, NSF has updated several sections of the 2013 *Proposal and Award Policies and Procedures Guide*. There is a comprehensive review of the changes here. A summary is below:

An overview of the upcoming PAPPG changes that impact Fastlane and proposal submission requirements are listed below:

- In lieu of one text box, the Project Summary will now have three text boxes to address "Overview", statement on "Intellectual Merit", and statement on "Broader Impacts".
- The Project Summary can only be uploaded as a pdf file if it contains <u>special characters</u>, and the corresponding box on the Project Summary page in FastLane has been checked.
- A limit of 1 page will be enforced for the Project Summary.
- FastLane will not accept a proposal without a Project Summary.
- Four additional proposal certifications have been introduced as part of the Cover Sheet.
- The Facilities, Equipment, and Other Resources form must be uploaded. A text box will no longer be available. The format of the form also has been revised.
- Proposal and Panel Review forms will now have an additional question to address strengths and weaknesses
 of the proposal with respect to any additional solicitation-specific review criteria.

Proposal Invitation in 2013 for Designing Materials to Revolutionize and Engineer our Future

The Division of Mathematical Sciences (DMS) of the National Science Foundation (NSF) is pleased to invite proposals in 2013 for the NSF activity **Designing Materials to Revolutionize and Engineer our Future (DMREF).**

DMREF comprises well-coordinated activities involving the Directorates of Mathematical and Physical Sciences, Engineering, and Computer & Information Science and Engineering. For further details and participating divisions please see the broadly aimed Dear Colleague Letter about DMREF in fiscal year 2013, posted for example on the MPS web page, NSF 13-025. As described in that Letter, success in the initiative requires a collaborative, synergistic, iterative approach that includes theory, computation, and experiments.

DMREF proposals submitted to the Division of Mathematical Sciences must:

- be submitted within the window 15 January 15 February 2013, inclusive;
- be submitted to DMS as the division and to DMREF as the program;
- deal with problems in the range of issues described in the DMREF Dear Colleague letter, NSF 13-025
- seek new mathematical or statistical results that will advance the DMREF agenda;
- describe a research plan that meets the central Materials Genome Initiative principle of closely coupled, iterative interplay among theory, computation, and experiment.

Participants interested in submitting proposals are **strongly encouraged** to first contact any of the program officers listed in the main DMREF Letter. For DMS, please confer with Michael Steuerwalt (<u>msteuerw@nsf.gov</u>).

ENTERING INTERNATIONAL COLLABORATIONS ON NATIONAL SCIENCE FOUNDATION (NSF) / GRANTS.GOV SUBMISSIONS:

When the project has activities outside the United States or partnerships with international collaborators, you must identify the countries involved.


NSF requires that the countries identified as International collaborators or activities outside of the U.S. are entered in accordance with the NSF Specific International Organization for Standardization (ISO) 2-digit code format.

A listing of each country and their 2-digit ISO code is listed on the OSP <a href="http://brown.edu/research/sites/brown.

EXAMPLE
