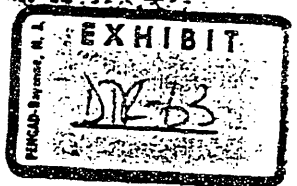

Time of Discussion early afternoon to late at night.

Formation of us and Hakim

1. Iran pays for 500 TONS to HAKIM and if willing, Iran will provide the funds for the HAKIM spare parts which remain from the earlier agreement.
2. In 9 working days; the 500 TONS and the HAKIM spare parts (pending Iran's approval), and free (gifted) medicines will be delivered to Iran.
3. Before item 4 as stated below is carried out, Albert will present the plan for the release of the 17 Kuwaitis imprisoned in Kuwait.
4. One and one-half (1 definitely and the 2 with empathic effort) American hostages in Lebanon, through the effort of Iran, will be freed from the hands of the Lebanese. (2-4 days after the delivery of point 2 item).

Establishing IRMI (100 members), within 7 days after the expiration of  
terms mentioned above, will be authorized to IRMI. IRMI will pay for money for  
1500 TWD and 500 TWD mentioned above and also additional 1000 TWD and 1000  
1000 TWD will be following to IRMI within one days. Ali

6. America will support IRMI with technical assistance, material and special  
know-how, reorganize the military intelligence, maps and communication links.  
Also prepare the Cart related to the items provided by Ali ~~XXXXXXXXXXXXXXXXXXXX~~  
~~XXXXXX~~ in writing prior to the delivery of IRMI.

7. Before returning to Beirut, the case of the civilian part of (prisoners) in  
Lebanon and the manner of their release should be studied with local and part  
involved.\*\*

8. IRMI will pursue its efforts in establishing the grounds for the release of  
the rest of the hostages.

9. The steps for delivery of items referred to in the second part of  
item 6 mentioned above will start.

The Letter of Credit will be opened in favor of Mr. Husaini and will make the  
money for the 500 TWD available by utilizing 80 percent of the Letter of Credit.

After discussion between Mr. Accord and Mr. Sami, it was agreed regarding to  
civilian prisoners that letter be written "Israel and its Land organization" Text  
will be written in the following manner . . .

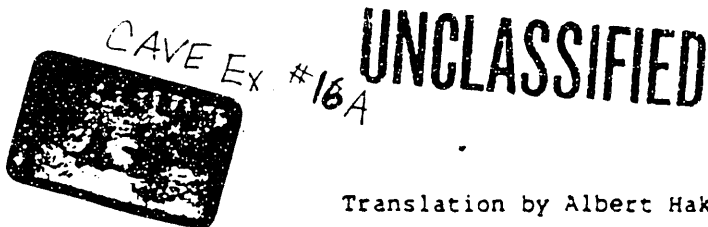

6. The United States will start with the technical support of the Hawks (material and know-how), update of the military intelligence and maps, establishment and commissioning of the special communication link.

- 8. Iran will continue its effort for creating the grounds for the release of the rest of the hostages.
- 9. The steps for delivery of items referred to in the second part of Item 6 above will start.
- \* The Letter of Credit will be opened in favor of Mr. \_\_\_\_\_ and he will make the money for the 500 TOWs available by using 80% of the Letter of Credit.
- \*\* After discussion between Mr. Secord and Mr. \_\_\_\_\_, it was agreed regarding regarding the Moslem prisoners that the sentence (text) will be written in the following manner:
