

Cost Sharing Reference Guide

COST SHARING	A portion of total sponsored project/program costs that are not funded by the sponsor. Cost sharing includes all contributions, including cash and in-kind, that the University makes to an award.			
COST SHARING TYPES:				
Mandatory Committed	Mandatory committed cost sharing is required by the sponsor as identified or quantified in the proposal budget and/or statement of work. Mandatory committed cost sharing is a condition of receiving the award and is a binding commitment of the University. This type of			
Salary Cost in Excess of Sponsor Imposed Cap	Salary costs that are over a sponsor imposed cap (e.g. NIH Salary Cap) are required to be tracked. All salary costs in excess of a sponsor imposed cap is considered mandatory committed cost sharing.			
Voluntary Committed	Voluntary committed cost sharing is not required by the sponsor; however, it was identified or quantified in the proposal statement of work and/or budget. Voluntary committed cost sharing becomes a binding commitment of the University when proposal is funded. This type			
Voluntary Uncommitted	Any cost associated with a sponsored project / program that was not identified in the proposal statement of work, budget, or in any other communication to the sponsor. Voluntary uncommitted cost sharing is a nonbinding commitment that is not required to be documented,
