Description of Site: Women & Infants' Hospital is the 11th largest obstetrical center in the country and one of the nation's leading specialty hospitals serving women and their newborns. Women & Infants' is a primary teaching hospital for Brown University. In 2003, Women & Infants' and Brown University were named a National Center of Excellence in Women's Health by the U.S. Department of Health and Human Services.

In addition to providing extensive obstetrical, gynecological, and pediatric services, Women & Infants has an active Women's Behavioral Health division which includes a consultation-liaison program that services obstetric, gynecological, and oncology units, an outpatient service and a specialized mother-baby psychiatric partial hospital. The mother-baby partial hospital (Day Hospital) is the first of its kind in the nation. The mission of this specialized partial hospital program is to provide timely, comprehensive, culturally sensitive treatment to women suffering from psychiatric disorders during both pregnancy and the postpartum period. It is designed to keep mothers and their infants together during treatment so that 1) the critical bonding period between mother and baby is not disrupted, 2) breastfeeding in nursing mothers is not interrupted and 3) direct observation of maternal interaction with her infant can occur. The Day Hospital is comprised of a multi-disciplinary treatment team that specializes in perinatal psychiatric disorders and serves an economically, ethnically and culturally diverse patient population.

Fellowship Aims

1. To provide the fellow with broad post-doctoral training in the area of women's mental health in general and perinatal mental health more specifically.
2. To provide the fellow with a strong working knowledge of the research base for treatment of antepartum and postpartum behavioral health issues.
3. To enable the fellow to gain experience working as part of a multidisciplinary team by providing individual as well as group clinical services to patients in the Day Hospital and outpatient programs.
4. The fellow will gain a strong working knowledge of evidence-based assessment of psychiatric disorders, symptoms, and related illnesses that occur more commonly in women.

Fellowship Timeline

This is a one-year fellowship with an anticipated start date of July 1, 2022.

Clinical Activity Plan (70% time)

The fellow will be expected to conduct biopsychosocial evaluations, serve as primary therapist for selected patients, facilitate both psychotherapy process groups and didactic skills groups, and participate in family therapy sessions in the partial hospital program. The fellow will conduct thorough intake evaluations, carry 1-2 long-term perinatal outpatients, and provide a longitudinal postpartum support group in the outpatient clinic.

By the end of the fellowship, fellows should:

1. Be able to conduct an initial intake assessment with pregnant and postpartum women presenting with psychiatric concerns (e.g., depression, anxiety, personality disorders). This includes conducting clinical interviews with patients and family members, contacting obstetrical providers for pertinent collateral information, and presenting clinical impressions and treatment recommendations to the patient.
2. Take into consideration health, cultural, linguistic, and familial factors in assessment and diagnostic conclusions, treatment approaches, and recommendations.
3. Be able to conduct mental status exams and lethality assessments when they are needed during assessment of adult women referred to the partial hospital program.
4. Be able to integrate information from history, observations, clinical interview, medical records, and formal testing to formulate diagnostic impressions, utilizing a multi-axial diagnostic format.
5. Be able to develop an appropriate treatment plan to address psychiatric disorders based on the available treatment literature.
6. Be able to implement behavioral interventions and interpersonal psychotherapy in individual and group formats to address psychological symptoms and related concerns (e.g. lack of attachment to infant, family problems). The fellow will be able to tailor interventions to the individual with consideration of factors specific to pregnancy and the postpartum period.
7. Demonstrate competence in treating pregnant and postpartum women with depression and other psychiatric conditions and be familiar with psychotropic medication recommendations for pregnant and breastfeeding women.
8. Conduct family sessions.
9. Be able to obtain collateral data from other providers (typically obstetrical) and social service agencies in order to construct a basic medical history, full psycho-social history and aid in discharge planning.
10. Be able to write a full intake report, including history of presenting problem, pregnancy and delivery history, social/developmental history, mental status exam, formulation, and recommendations.
11. Be able to write accurate, concise, and timely treatment notes.

12. Be able to communicate effectively with members of multidisciplinary teams in order to coordinate care, gather medical information, and to assist team members in understanding psychological factors relevant to the care of the patient.
13. Make effective case presentations, eliciting feedback from colleagues and supervisors to enhance care.

Research Activity Plan (20%)

The fellow will be exposed to various aspects of perinatal mental health clinical research work. This is achieved via participation in the following activities:

- Review of perinatal mental health literature: The fellow will be provided with a series of readings in the area of perinatal mental health in general
- Manuscript preparation and submission: The fellow will be encouraged to collaborate on manuscript preparation and poster submission at national conferences. Individually tailored goals will be established in this area.

Didactics (10% time)

Postdoctoral Seminars: The fellow will participate in the following postdoctoral seminars through the Brown Post-Doctoral Training Program.

Supervision and Evaluation

Clinical supervision will be provided in the form of one-hour weekly face-to-face individual supervision blocks with licensed clinical psychologists on site as well as two additional hours of group and/or individual supervision per week. An additional hourly block of individual, face-to-face supervision will be offered for research supervision. The Fellow also will have access to several additional forums for direct and indirect supervision through optional participation in regularly scheduled rounds and treatment teams with members of the interprofessional teams.

The Fellow and supervisors will develop fellowship goals and learning objectives early in the first year. At the midpoint and conclusion of the Fellowship, the Fellow and supervisors will provide formal performance evaluations of one another.

Resource Requirements

Fellow will be provided with the following resources at Women and Infants Hospital:

- Access to space to complete clinical responsibilities
- For CPP fellows, individual office space is provided
- A computer and position-specific software
- Internet access
- Telephone
