## DECLARATION OF DOMESTIC PARTNERSHIP

- 1. We hereby certify that, as same-sex domestic partners, we have an exclusive mutual commitment similar to marriage and that we meet the following criteria:
  - We have been each other's sole domestic partner and have shared a common residence for at least the last twelve (12) consecutive months and we have every intention of remaining indefinitely in the relationship. (Please complete the *Certification of Residency* form included with this packet).
  - Neither of us is married to anyone else.
  - We are jointly responsible for each other's common welfare and basic living expenses.
  - We are both at least 18 years old and are mentally competent to consent to contract.
  - We are by law adults and are not related by blood closer than would bar marriage in our state of legal residence.
- 2. We agree to notify Brown University if the status of this relationship changes include termination of the relationship or failure to meet any of the above criteria by filing a *Change of Status* form with the Brown to Brown program coordinator (Tracy Mansour, Box 1902) no later than 30 days from the date of such change. It is understood that if this domestic partnership is terminated, a subsequent *Declaration of Domestic Partnership* cannot be filed until the later of 12 months after filing a *change of Status* form or 12 months after coverage has been cancelled.
- 3. We understand that the information contained in this Declaration is confidential and is being provided for the sole purpose of identifying the same-sex domestic partner of the Brown to Brown participant, who may be subject to certain rights and restrictions contained in the Brown to Brown Program.
- 4. We affirm that the statements attested to in this Declaration are true and correct to the best of our knowledge. We understand that we are responsible for reimbursing Brown University for any expenses incurred as a result of any false or misleading statement contained in this Declaration. It is further understood that a false statement could result in disciplinary or legal action, including termination of employment at Brown.
