## OSP / OVPR/ RPO UPDATES

### ➤ Assistance with the NIH Public Access Policy Now Available

OSP is pleased to announce that Laura Pavlech, DVM, MSLS, has recently joined the Brown University Library as the Biomedical and Life Sciences Librarian. Dr. Pavlech can provide NIH Public Access Policy training; including the core requirements of the policy, how to comply with the policy, and managing compliance with My NCBI for departments, institutes and centers.

### ➤ Winter Break Proposal Submission Deadlines

OSP/BMRA will process proposals due in **December and January** according to the University's five-day proposal submission policy with the following exceptions:

- Proposals with **deadlines that fall between December 23<sup>rd</sup> and January 2<sup>nd</sup>**, the due date to OSP/BMRA is 5pm on Tuesday, December 16th.
- For proposals **due on January 7<sup>th</sup>**, all non-science sections are due by Friday, December 19th with final technical/science sections due by 12pm on Monday, January 5<sup>th</sup>.

## ➤ **Workday Effort Reporting Implemented October 8, 2014**

Over the past year, the Office of Sponsored Projects and the Workday Operations Team have collaborated to develop Workday Effort Reporting. **This new functionality went live on October 8th for non-exempt and undergraduate student workers who currently certify monthly.** In early January, we will be releasing this new functionality for faculty, graduate students, and exempt staff who certify semi-annually (July 1 – December 31).

The Workday Effort Reporting functionality has replaced our current manual, paper processes and allows for the online distribution of effort reports and online certification of effort. A new report, *Effort Certification Summary Report*, has been created to enable Effort Certification Partners to easily track the status of their effort reports.

### NIH UPDATES

#### ➤ Upcoming eRA Systems Maintenance

All eRA systems will be down for maintenance on the following dates:

<b>Oct. 16-17</b>	9 pm to 7 am ET Thu-Fri	System-wide software release	All eRA systems (including eRA Commons, eSubmission and all IMPAC II modules) and databases will be unavailable
<b>Nov. 1-2</b>	10 pm – 5 am ET Sat – Sun	Scheduled weekend maintenance	All eRA modules, databases and web sites will be unavailable (including eRA Commons, eSubmission, iEdison, all IMPAC II modules and the RePORTER web site)

#### ➤ Inclusion Management System (IMS)

The NIH is mandated by law to ensure the inclusion of women and minority groups in clinical research. On October 17, 2014, eRA Commons will be implementing a new feature known as the Inclusion Management System (IMS). IMS is replacing the existing Population Tracking System to ensure the appropriate reporting of sex/gender, race, and ethnicity information as required by the NIH Policy on the Inclusion of Women and Minorities in Clinical Research.

Key Changes as of October 17, 2014 and beyond:

- Inclusion enrollment report forms received with competing application submissions will automatically populate the IMS.
- NIH grantees completing their Research Progress Performance Reports (RPPRs) will be prompted in Item G.4.b to access and update inclusion records directly in IMS.
- Grantees will be able to access their inclusion enrollment data through the IMS, found through the eRA Commons Status page, and can review or update their inclusion data as needed.
- NIH will migrate ongoing enrollment information from the previous data system to the IMS. The report format has been adjusted; as a result, grantees will be required to update Cumulative Inclusion Enrollment data in the IMS format at the time of the RPPR.

#### ➤ Reminder for Investigators with Early Stage Investigator (ESI) Status

In order for eRA systems to identify a Project Director/Principal Investigator (PD/PI) on a R01 or DP2 application as having Early Stage Investigator (ESI) status, the PD/PI's degree completion and/or the end of residency date must be correctly entered in the eRA Commons profile at the time of submission.

If you have submitted an application and it does not reflect the correct Early Stage Investigator status, you need to open a ticket with the [eRA Commons Help Desk](#) to request a correction for the submitted application.

<p><b>DOE UPDATE</b></p>	<p>➤ <b>Department of Energy Guidance on the Supercircular</b></p> <p>The Department of Energy has presented their perspective on the Supercircular (aka Omnicircular), formally titled 2 CFR 200, which encompasses all previous federal award guidance and becomes effective December 26, 2014. It streamlines Federal awards to ease administrative burdens and also strengthens oversight of Federal funds to reduce risk of waste, fraud and abuse. <p><b>NASA UPDATE</b></p>	<p>➤ <b>NASA Guidance on Avoiding Grant Delays</b></p> <p>The NASA Shared Services Center (NSSC) is the NASA organization that issues grants to non-civil servant PIs. They report the number one cause of grant delays is a failure on the part of the proposer to submit accurate budget rates from their institution including approved indirect rates and appropriate justification for expenditures (see the <a href="#">budget details FAQ</a> and the <a href="#">Guidebook for Proposers</a> for instructions). The more detail in your budget justification (or narrative) the less likely your grant will be delayed. Try to explain procurements in a manner that would be understood by a non-scientist, but with enough detail so that they know what will be purchased. See the <a href="#">NASA How to Guide</a> for details.</p>

## COEUS UPDATES

### COEUS Tip of the Month

#### ➤ Completing Rolodex Entries for Non Brown Contacts

When adding Non Brown individuals to proposals and protocols, make sure you enter complete Rolodex entries.

**Complete Rolodex entries consist of the following required fields:**

<b>First and Last Name</b>	<b>Postal Code</b>
<b>Organization</b>	<b>Country</b>
<b>Address Line 1</b>	<b>Phone Number</b>
<b>City</b>	<b>Email Address</b>
<b>State</b>	

#### Things to Keep in Mind:

- Do not use special characters (such as Ü) in any Rolodex entry.
- Do not copy and paste information into the Rolodex entry. This can result in “hidden” special characters that can cause an application to be rejected by Grants.gov.
- Enter phone/fax Numbers in one of the following formats:  
XXX-XXX-XXXX or XXXXXXXXXXXX
- Make sure the postal code is 9-digits long (Do not include a dash between the first 5 digits and the last 4 digits).
- You will only be able to modify Rolodex entries that you created. If a contact has a misspelling or known address change and you cannot modify the entry, please contact [Coeus\\_Help@brown.edu](mailto:Coeus_Help@brown.edu) to have the record updated.

## POST-AWARD UPDATES

### ➤ Fly America Act – Open Skies Agreements

- Travelers supported by federally funded projects must use a U.S. Carrier under the "Fly America Act".
  - One exception to this requirement is transportation provided under a **bilateral** or **multilateral** agreement. There are currently **four bilateral/multilateral "Open Skies Agreements" in effect:**
    - [United States \(US\) Government and the European Union \(EU\)](#) effective April 30, 2007 [US-EU Amendment](#) effective June 24, 2010, and [US-EU Amendment](#) effective June 21, 2011
    - [United States \(US\) and Australia](#) effective October 1, 2008
    - [United States \(US\) and Switzerland](#) effective October 1, 2008
    - [United States \(US\) and Japan](#) effective October 1, 2011

**\*Please note:**

- The exceptions noted above do not apply to Department of Defense funded awards.
- 3 of the agreements (Australia, Switzerland, and Japan) also require that there is no City Pair Program in effect.

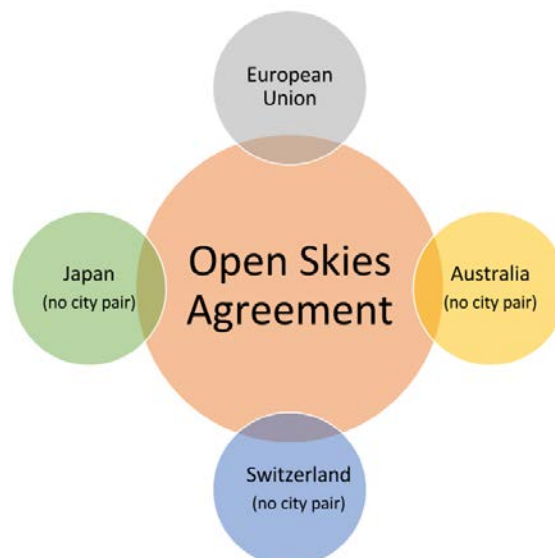

### OPEN SKIES PARTNERS:

The Department of State references a PDF document that lists "[Open Skies Partners](#)". This is **NOT** part of the Fly America Act Open Skies exception and **should not be used** as a reference when making a decision on an approved carrier.

- **Example:** Canada is included in the Full List of "Open Skies Partners" but not under one of the 4 bilateral/multilateral agreements. Therefore, Canadian Airlines would **NOT** qualify as an Open Skies exception under the Fly America Act.

### ➤ Checking Sponsored Award Budgets In Workday

When you receive notification from OSP that a new award or an award modification was processed, please review and verify the budget in Workday.

#### To Review Budget:

Run the Manager Budgetary Balance Report and verify that funding has been apportioned to the correct ledger accounts and that the total budget amount is accurate. Notify your Grant/Contract Accountant if changes are required.

### ➤ Inactivation Of Grant Worktags

WD Operations Team and OSP are in the final stages of testing inactivating grant worktags:

- **Phase 1 – Underway** - Inactivation of grant worktags for closed awards that were converted
- **Phase 2 – October / November** - Inactivation of grant worktags for awards closed and reconciled in FY14

Grant worktags with a status of inactive will not be allowed on transactions initiated in Workday; e.g. supplier invoice, expense report, costing allocation. The grant worktag will appear in the pick list but the inactivation will be clearly denoted, i.e

**GR524567 (INACTIVE)**

Inactive Grant worktags will still be available for reporting purposes and the associated Bat Keys will be disabled.
