OSP / OVPR UPDATES

➤ Vice President for Research David Savitz and Deputy Vice President for Research Sue Alcock Announce the Creation of Research Development & Support Services

We are pleased to announce that we are reorganizing those activities in the Office of the Vice President for Research previously identified as the Research Initiatives Office and the Research Opportunities Office into a single unified effort, *Research Development & Support Services (ReDSS)*. In this period of limited federal funding, the Office of the Vice President for Research has been assigned a leadership role in expanding research funding following a recent decline. The goal of this reorganization is to improve the process by which we identify funding opportunities, engage faculty to develop funding applications, and increase the likelihood of those efforts being successful.

The mission of ReDSS is to identify, develop and implement strategies that increase institutional research capacity and competitiveness. The Office will work to link funding agencies and faculty researchers both to find opportunities where Brown can compete for outside funding, not least large multi-investigator awards, and to provide direct assistance to the faculty who are developing such proposals.

➤ NSF Proposal Submission Error – Recent Example

In order to provide the most current interpretation of sponsor proposal submission requirements please see the text below. The email was received in August from NSF's Division of Social and Economic Sciences (SES) Methodology, Measurement and Statistics Program:

 “This email concerns your recent submission to the Methodology, Measurement and Statistics Program (MMS; [NSF 12-510](#)). According to the National Science Foundation [Grant Proposal Guide](#), your proposal is not compliant for the following reason(s):

- *In the Facilities, Equipment, and Resources section, you have not submitted permissible descriptions about the facilities, equipment, etc. Descriptions cannot go beyond basic identification of the facilities to be used, and, as appropriate, indicating their pertinent capabilities relative to the project and extent of availability to the project. We are looking for specifics to your project, not “boilerplate” descriptions. Please remove or revise any sections that do not discuss the resources directly applicable to your project.”*

 To date, OSP has not received similar remarks from other NSF Directorates, however we recommend following the Grant Proposal Guidelines closely during proposal development.

UPDATE➤ **Grant and Contract Submission Requirements Regarding the AVMA Guidelines for the Euthanasia of Animals: 2013 Edition**[NOT-OD-13-098](#)

The NIH Office of Laboratory Animal Welfare (OLAW) oversees PHS-funded animal activities by the authority of the [Health Research Extension Act of 1985](#) and the PHS Policy on Humane Care and Use of Laboratory Animals ([Policy](#)). The [PHS Policy, IV.D.](#), requires that applications and proposals for awards that involve the care and use of animals shall contain a description of any euthanasia method to be used.

The American Veterinary Medical Association (AVMA) issued and posted an update to the 2007 Guidelines on Euthanasia with a new title, **AVMA Guidelines for the Euthanasia of Animals: 2013 Edition** available at <https://www.avma.org/KB/Policies/Documents/euthanasia.pdf> (PDF). The PHS Policy requires that euthanasia be conducted according to the AVMA Guidelines on Euthanasia. **After September 1, 2013**, the Vertebrate Animal Section (VAS) of grants and contracts must be consistent with the 2013 Guidelines. In their submission to NIH, grant applicants and contract offerors are required to describe any method of euthanasia to be used and the reasons for its selection and to state whether the method proposed is consistent with the 2013 AVMA Guidelines. If the proposed method is not consistent with the AVMA Guidelines, a scientific justification must be included in the VAS.

➤ **Notice of NIH Guidance on the Family Acknowledgement and Use of HeLa Cell Whole Genome Sequence Data**[NOT-OD-13-099](#)

NIH strongly encourages all grantees, contractors, and NIH researchers proposing to generate HeLa cell whole genome sequence data to include a plan for submission of these data to the database of Genotypes and Phenotypes (dbGaP) as part of the "Research Sharing Plan" provided with each application. The plan should include provisions for the data to be added to the dbGaP study page for HeLa Cell Genome Sequencing Studies, and an acknowledgement that the researcher has read and will agree to the provisions of the HeLa Genome Data Use Agreement (available at http://dbgap.ncbi.nlm.nih.gov/aa/wga.cgi?view_pdf&stacc=phs000640.v1.p1).

NIH also encourages grantees who have used or generated HeLa whole genome sequence data that is under controlled access in dbGaP to acknowledge Henrietta Lacks and her family by using this sample language (or something similar) in their publications, presentations, or other public reporting of research using these genomic data:

"The genome sequence described/used in this research was derived from a HeLa cell line. Henrietta Lacks, and the HeLa cell line that was established from her tumor cells without her knowledge or consent in 1951, have made significant contributions to scientific progress and advances in human health. We are grateful to Henrietta Lacks, now deceased, and to her surviving family members for their contributions to biomedical research. This study was reviewed by the NIH HeLa Genome Data Access Working Group (<http://acd.od.nih.gov/hlqda.htm>). The genomic datasets used for analysis described in this manuscript were obtained from the database of Genotypes and Phenotypes (dbGaP) through dbGaP accession number phs000640.v1.p1."

➤ **Extension of eRA Commons User IDs to Individuals in Graduate and Undergraduate Student Project Roles with Measurable Effort on an NIH Annual Progress Report (PHS2590 & RPPR)**[NOT-OD-13-097](#)

On August 15, 2013, the NIH made Undergraduate, Graduate Student, and other project personnel roles available in eRA Commons and over the next year NIH will start requiring an eRA Commons ID for all individuals in Graduate and Undergraduate Student roles who participate in NIH-funded project for at least one person month or more. That

information will appear on NIH progress reports (PHS2590 and RPPR).

- Beginning on **October 18, 2013** a **warning** will be generated when an RPPR is submitted that lists individuals in a Graduate or Undergraduate Student role who have **not** established an eRA Commons ID.
- Beginning in **October 1, 2014**, RPPRs lacking the eRA Commons ID for Graduate and Undergraduate Students will receive an **error** and the RPPR will not be accepted by the NIH without this information.

In addition, Graduate students and Postdocs who complete their eRA Commons Profile will be required to answer certain demographic questions related to their date of birth, gender, race, ethnicity, disabilities, US citizenship status and country of citizenship; and where applicable, they will need to indicate their highest educational degree and the institution where it was earned, in order to complete the data collection. For items that request information on gender, race and ethnicity, and disability one of the acceptable responses will be "I Do Not Wish to Provide".

Once phased in, this new policy will extend the existing eRA Commons ID requirement for Program Directors/Principal Investigators (PDs/PIs) and postdoctoral researchers. In addition to providing information on PD/PIs and those in the training phases of their careers, grantee institutions will be encouraged to create an eRA Commons Account for all other personnel listed on the All Personnel List of the PHS 2590 or in the Participant Section (D.1) of the RPPR. This new collection will provide more comprehensive information about the size and nature of the biomedical research workforce.

➤ **Dear Colleague Letter – Announcement of Intent to use an Asynchronous Review Mechanism for Proposals submitted to the Physics Division during the FY2014 Competition**

Date: August 8, 2013

This message is to inform you that the Physics Division will be reviewing proposals submitted for review during the FY2014 competition using a combination of *ad hoc* and panel review. The panel review portion may use an asynchronous mechanism the Division piloted in FY2013. The review principles remain the same as those with which you may already be familiar. The only mechanistic difference is that panel members are able to review and provide input to the panel discussion in the weeks prior to the panel meeting rather than limiting the discussion to the narrow range of time dedicated to the face-to-face panel meeting itself. Our experience with the pilot indicates that the extra time that this mechanism allows can lead to a more thorough examination of all the proposals by the full panel and hence more useful input to the NSF and feedback to the PIs. In the course of implementation, all normal rules of conflict of interest and confidentiality of information will apply.

It is important to stress that the review will strictly follow the established NSF review criteria of intellectual merit and broader impact. Each of the PHY Program Officers will decide on whether to employ this asynchronous mechanism or to continue their review process as they have in the past. NIH/NSF UPDATE	<p>➤ NIH-NSF Ecology and Evolution of Infectious Diseases Program: A joint Program for Multidisciplinary Research</p> <p>NOT-TW-13-010</p> <p>The Fogarty International Center (FIC) and the National Institute of General Medical Sciences (NIGMS) of the National Institutes of Health (NIH), the National Science Foundation (NSF) and the United States Department of Agriculture (USDA) have identified ecological and evolutionary sciences, including field biology and mathematical modeling, and socio-ecology as essential disciplines to understand and predict transmission of zoonotic and other infectious diseases that involve biotic or abiotic vectors, including diseases of humans, other animals, and plants. As described in the NSF Program Solicitation (NSF-13-577), the purpose of this Ecology and Evolution of Infectious Diseases (EEID) Program is to support multidisciplinary teams in the development of predictive models that integrate ecology and evolution with the goal of discovering principles governing the transmission dynamics of infectious disease agents to humans and other hosts.</p> <p>Application submission is through the National Science Foundation and potential applicants are strongly encouraged to contact NIH or NSF program officials prior to submitting an application. It is anticipated that eight awards will be made through this program in fiscal year 2014 for projects to begin in the summer of 2014. The maximum total (for all years) award size is \$2.5 million, including indirect costs, and the maximum award duration is five years. Awards made by components of the NIH may receive support of up to \$350,000 in direct costs per year for up to five years. The proposal deadline is November 20, 2013.</p>
DOD UPDATE	<p>➤ FY 2014 Multidisciplinary Research Program of the University Research Initiative (MURI)</p> <p>This Department of Defense (DoD) program is focused on multidisciplinary research efforts where more than one traditional discipline interacts to provide rapid advances in scientific areas of interest to the DoD (see full announcement for 2014 topics at http://www.grants.gov/web/grants/view-opportunity.html?oppld=240153).</p> <p>White Paper Due Date: 10/15/2013</p> <p>Award Information: Typically \$1.25M - \$1.5M per year for 3 years, with a 2 year option period.</p>



Agency Tip

NIH Applicants: Paper Size Matters!

In July 2013, NIH implemented system validation to enforce the 8.5 x 11 inch paper size limit for documents included within the application. Prior to that date, this page size requirement was not systematically enforced.

With that said, NIH will now systematically enforce paper size; however, the system will not throw an ERROR message until the file is well out of the paper size range (bigger than 9 x 12 or 12 x 9). **NIH Staff however will continue to strictly enforce 8.5 x 11 inches for the attachments with page limits.**

Also, NIH is phasing out the resizing of documents. If an attachment is submitted that is bigger than 8.5 x 11 inches and the assembled image is not formatted correctly in eRA Commons (i.e. text falls off the page or the footers overwrite document text) it will **not** be considered a system issue and will **not** allow corrections after the deadline. As always, it is highly recommended to submit the application early and carefully check the assembled application image in eRA Commons before the deadline while corrections are still possible.
