Research Administration Updates	<p>➤ NIH Notice on Salary Limitation for Grants and Cooperative Agreements</p> <p>NOT-OD-17-049 Effective January 8, 2017, the Executive Level II salary increased from \$185,100 to \$187,000.</p> <p>For awards issued in those years that were restricted to Executive Level II (see Salary Cap Summary, FY 1990 – FY 2016), including competing awards already issued in FY2017, if adequate funds are available in active awards, and if the salary cap increase is consistent with the institutional base salary, grantees may rebudget to accommodate the current Executive Level II salary level. However, no additional funds will be provided to these grant awards.</p> <p>The Office of Sponsored Projects has revised the NIH Salary Cap Worksheet to incorporate the new salary cap. Please note that both the proposal stage and award stage of the worksheet have been updated with the new salary cap.</p> <p>➤ NIH Operates Under a Continuing Resolution (CR)</p> <p>NOT-OD-17-049, NOT-OD-17-001, NOT-OD-16-046 The Department of Health and Human Services (HHS), including NIH, operates under the “Further Continuing and Security Assistance Appropriations Act, 2017,” (Public Law 114-254) signed by President Obama on December 10, 2016. This Act (CR) continues government operations through April 28, 2017 at 99.8099 percent of the FY 2016 enacted level. Some highlights of this Act include:</p> <ul style="list-style-type: none"> • The NIH will issue non-competing research grant awards at a level below that indicated on the most recent Notice of Award (generally up to 90% of the previously committed level).

- Upward adjustments to awarded levels will be considered after FY 2017 appropriations are enacted, but NIH expects institutions to monitor their expenditures carefully during this period. All legislative mandates that were in effect in FY 2016 (see [NOT-OD-16-044](#) and [NOT-OD-16-048](#)) remain in effect under this CR.
- The Ruth L. Kirschstein National Research Service Award postdoctoral stipend levels and tuition/fees for FY 2017 are described in [NOT-OD-17-003](#). Until further notice, the undergraduate and predoctoral stipends and tuition/fees will remain at the levels announced in [NOT-OD-16-062](#).

The Office of Research Integrity is pleased to announce its release of a comprehensive [Export Control Compliance Manual](#). The purpose of the manual is to provide guidance on U.S. Export Control laws and regulations, to identify key export compliance issues related to research, education, and all other activities conducted within a university setting, and to describe how Brown implements its [Export Control and U.S. Economic Sanctions Policy](#). The procedures outlined in the manual serve as Brown's program of internal controls, safeguards and educational measures designed to minimize risk of potential violations of all applicable export control laws and regulations and institutional policy. It's important to note that Brown's institutional policy and procedures outlined in the manual apply to all University personnel, defined as "Brown University faculty, staff, visiting scientists, postdoctoral fellows, students, and anybody who is paid by or otherwise engaged by Brown to conduct research, teach, or provide services at or on behalf of the University." NIH UPDATE

➤ **eRA Enhancements: Electronic Prior Approval Requests & xTRACT Enhancements Releases March 2**

This release now allows requests for No Cost Extensions requiring a prior approval and requests to change Program Director/Principal Investigator (PD/PI) to be made through the Prior Approval section of eRA Commons.

These features currently only apply to NIH awards and are an optional method. You should contact your awarding Institute/Center to determine the best method for making these requests before initiating either a No Cost Extension requiring prior approval or Change of PD/PI.

Additionally, this release added several new enhancements to xTRACT, the [Extramural Trainee Reporting and Career Tracking](#) system that is accessed via eRA Commons. It allows applicants, grantees and assistants to create research training tables for progress reports and institutional training grant applications. The enhancements include:

Participating Faculty Upload:

- The length of each faculty member’s research interest is now validated, and an error message is displayed if it exceeds the maximum of 60 characters.

Copy Research Training Dataset (RTD) Features:

- Some users had occasionally encountered an unexpected error upon attempting to copy a prior RTD. This issue has been corrected.

Correct Mean Values Displayed Properly:

- When preparing the data for Pre-doctoral Applicants/Entrants, the mean values for Total Applicant Pool and Applicants Eligible for Support were sometimes displayed on the Summary tab in reverse order. This has been corrected.

➤ **Mid-career Investigators and Shifting Demographics of NIH Grant Recipients**

The Office of Extramural Research’s (OER’s) Statistical Analysis and Reporting Branch and the National Heart Lung and Blood Institute analyzed concerns of mid-career investigators by looking at the association of NIH-funding with age. Using age as a proxy for career stage, the authors analyzed funding outcomes for three groups: principal investigators (PIs) aged 24 – 40, 41-55 (the mid-career group), and 56 and above.

Highlights of the findings include:

- The proportion of NIH investigators falling into the 41-55 age group declined from 60% (1998) to 50% (2014).
- Regardless of age, applicants have an approximately equal chance of having a new or renewal application funded.
- Multiple grants may confer an “enhanced survival benefit”, as PIs with multiple grants have a salary-support buffer that enables them to remain in the academic research system.
- The funding spread is further enhanced by the distribution of certain types of research programs, such as P01 awards, which support multi-project research projects.

<p>NSF UPDATE</p>	<p>➤ New NSF Proposal & Award Policy Newsletter</p> <p>The Policy Office in the Division of Institution & Award Support at the National Science Foundation has released a new quarterly publication designed to provide information about upcoming changes and clarifications to policies and procedures that affect how NSF awards are prepared and submitted. The first issue of the NSF Proposal & Award Policy Newsletter is now available on the Policy Office website.</p> <p>➤ Frequently Asked Questions (FAQs) Concerning Public Access to Research Results</p> <p>On March 7, 2017, NSF published answers to Frequently Asked Questions (FAQs) concerning public access to research results (NSF 17-060). Additional details can be found in the special report: Public Access to Results of NSF-funded Research.</p> <p>➤ Removal of Deadlines for Programs in the Division of Earth Sciences (EAR)</p> <p>The Division of Earth Sciences (EAR) will eliminate all future target dates for the following programs: Tectonics, Petrology, Geochemistry, Geophysics, and EarthScope. Submission of new proposals should be submitted after July 24, 2017. <p>Other Federal Updates</p>	<p>➤ New Research Terms and Conditions (RTC) Published</p> <p>The revised Research Terms and Conditions (RTC) was announced in the March 14, 2017 Federal Register. The RTCs address and implement the <i>Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (2 CFR 200)</i> issued by the U.S. Office of Management and Budget (OMB). Revision of the RTCs and accompanying documents is an initiative of the Research Business Models (RBM) Interagency Working Group.</p> <p>NSF has agreed to continue to serve as the sponsor of the updated version of these RTCs, which are accessible on the NSF website at: https://www.nsf.gov/awards/managing/rtc.jsp. In addition to the Federal Register notice, the following documents are now posted on the NSF website, and are dated March 14, 2017, for consistency with the date specified in the Federal Register notice:</p> <ul style="list-style-type: none"> · Research Terms and Conditions; · Appendix A Prior Approval Matrix; · Appendix B Sub award Matrix; and · Appendix C National Policy Requirements. <p>The RTCs will apply to an award when they are included as part of that award, or when incorporated into that award by reference. 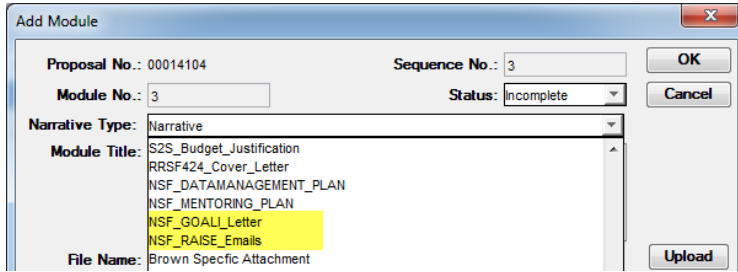

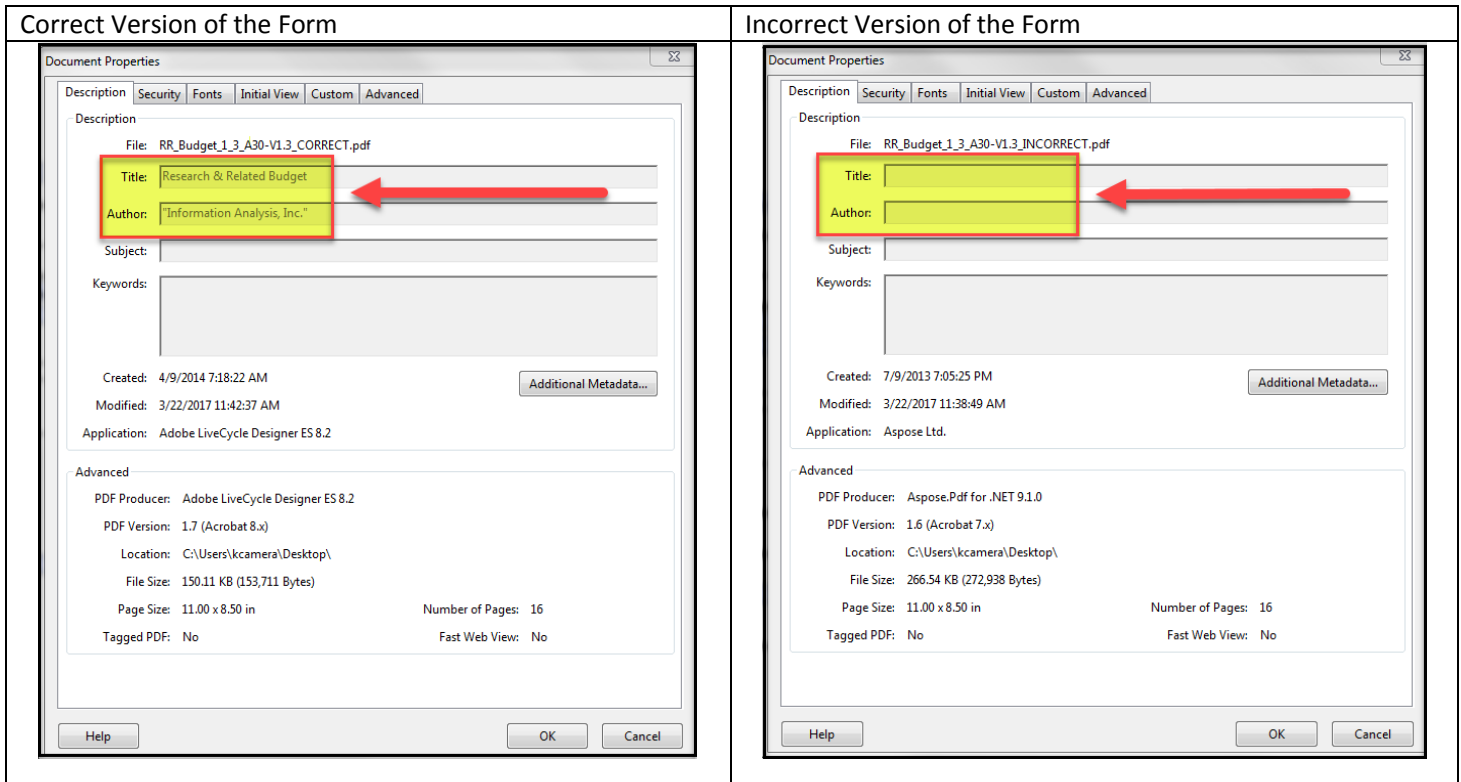
*New NSF Validations to replicate the compliance checks around these new requirements will be implemented in early April.

➤ Tip to Confirm You are Using the Correct Version of the Subaward Budget Forms

When submitting your proposal “System-to-System” from Coeus, you must use the correct version of the R&R Subaward Budget form for that opportunity package. **If you do not use the correct version, the proposal will receive a Grants.gov error and will not be sent to the agency.**

We have identified a method to check if you are using the correct version of the form so you can identify the issue prior to uploading into Coeus:

- Open the Document Properties of the Subaward Budget PDF by going to File > Properties.
- Review the **Title Field**. The field should contain **“Research & Related Budget”**



- **If you see “Research & Related Budget”** in the Title Field – that indicates that the correct version of the form is being used.
- **If you do not see “Research & Related Budget”** in the Title Field – You will need to Transfer your Subaward Budget Details on to the correct version of the form.
